

## **Chew Valley Lake Reservoir Run - terms and conditions applicable to participants**

These terms and conditions apply to all participants who register to take part in the Event. By registering for, and/ or participating in, this Event you are agreeing to be bound by these terms and conditions.

Under these terms and conditions a participant will also be referred to as “you”.

### **A. DEFINITIONS**

Under these terms and conditions the terms detailed below have the following meanings attributed to them:

- **“Bristol Water”**: means South West Water Limited, a company incorporated in England and Wales with Companies House registration number 02366665 whose registered office is at Peninsula House, Rydon Lane, Exeter, Devon, EX2 7HR, trading as ‘Bristol Water’.
- **“Event”**: means the *Chew Valley Lake Reservoir Run* on the 5 October 2025, organised by The Event Organiser on behalf of Bristol Water.
- **“Event Organiser”**: means Project Thirty Limited a company incorporated in England and Wales with Companies House registration number 12506550 whose registered office is at 2 Middleton Road, Bournemouth, England, BH9 2SU.

### **B. TERMS**

#### Assumption of risk

1. You acknowledge that participation in the Event (whether that be running, walking, or otherwise) involves inherent risks, including but not limited to: slips, falls, overexertion, dehydration, muscle cramps, stress fractures, cardiac events, heat stroke, hypothermia, injury from uneven terrain, accidents involving vehicles or other participants, or even death. You voluntarily accept and assume all such risks, both known and unknown.

#### Entry requirements (including minimum age)

2. **All children under the age of eighteen (18) years must have an adult in attendance at the Event.**
3. **Minimum age of participation for the Event is five (5) years old.**
4. **Children aged five (5) to ten (10) years must be accompanied by an adult at all times during the entirety of the Event. Furthermore, the maximum distance they are permitted to run is five (5) km.**
5. **Those children aged from eleven (11) to seventeen (17) years are eligible to run the course alone, should they wish to do so.**
6. You are responsible for reading the details and description of the Event on the Website, as well as any other information that will be provided to you by the Event Organiser.
7. You confirm that you are in good health sufficient your for participation in the Event, and have adequate training and experience to participate in the Event.
8. You confirm that have no medical condition that would make your participation in the Event unsafe for you and/ or others. You acknowledge that it is your responsibility to seek medical clearance prior to participating in the Event.
9. If at any time it is discovered that any participant should have been ineligible to participate in the Event (or if participation in the Event should have been refused for any reason whatsoever), the

Event Organiser reserves the right to refuse entry to such participant or disqualify such participant from the Event.

### Fees and cancellation

10. The value of the fee for participation in the Event is stated at the point of registration and that fee must be paid in full at the time of registration.
11. All entries are non-transferrable between individuals unless specifically agreed with the Event Organiser in writing via email at [chewvalleyrun@project-30.co.uk](mailto:chewvalleyrun@project-30.co.uk).
12. Cancellations made within twenty-one (21) days or less of the Event date will not be eligible for a transfer for whatever reason (this includes Covid 19 and associated illnesses).
13. Due to the nature of the Event as a charitable fund-raiser, no refunds shall be given for cancellations for whatever reason (this includes Covid 19 and associated illnesses).
14. If any details provided by you on your registration form change then you must notify the Event Organiser **immediately** by e-mail to [chewvalleyrun@project-30.co.uk](mailto:chewvalleyrun@project-30.co.uk).
15. The Event Organiser reserve the right to cancel your participation in the Event if any information provided by you is found to be inaccurate in any way. In such a case, you will not be entitled to a refund or Event transfer.
16. All arrangements for the Event (including but not limited to: the venue for the Event; the date of the Event; and, the Event scheduling) may be subject to change. Any changes will be notified to you as soon as possible via e-mail. No refund will be issued if you cannot make the rescheduled time, date, venue, etc.
17. If access to the published race course is restricted for any reason, an alternative route will be used. The Event Organiser will notify all participants via email at the earliest possible opportunity.
18. If the Event has to be postponed for any reason deemed necessary by the Event Organiser, an alternative date and time will be arranged and you will be notified of this accordingly. These terms and conditions apply to the rearranged Event, also. No refund will be given if you do not wish to participate in the rearranged Event. No accommodation or travel fees will be refunded if the Event is rescheduled.
19. If the Event is cancelled by the Event Organiser then you will receive a refund of your registration fee minus a twenty per cent (20%) deduction to cover administration costs.
20. No refunds will be payable if cancellation or changes are due to:
  - 20.1. war, threat of war, riot, civil strife, industrial dispute, terrorist activity;
  - 20.2. natural or nuclear disaster, fire, adverse weather;
  - 20.3. pandemic or epidemic; and or
  - 20.4. any other circumstance amounting to force majeure.
21. The Event Organiser and Bristol Water are not liable for any other losses, such as travel or accommodation expenses.

### Rules and regulations

22. You must abide by any rules or regulations of this Event that may be notified to you by The Event Organiser or Bristol Water at any point leading up to or during the Event.
23. For your own safety and those of others, the use of headphones is not permitted during this Event.
24. Please ensure you dispose responsibly of your rubbish. Do not leave rubbish on trails, etc. If no bin is available, please take rubbish away with you. The Event Organiser will always have bins available at race registration, checkpoints, and finish sites. Anyone found to be disregarding this rule will risk being disqualified from the Event.
25. Please show respect and courtesy towards other participants, spectators, the general public, and the Event Organiser's members of staff. If you are found to be behaving in a manner that is not in keeping with the nature of the Event (e.g., poor sportsmanship, risking the safety of other participant(s), spectators, members of staff, or the general public), as deemed so by the Event Organiser, you will be removed from the Event and no refund will be given.

26. No unauthorised trading is permitted at the Event (including on trails and car parking facilities).

### **Insurance and liability**

27. You attend the Event (whether as a participant, spectator, or otherwise) entirely at your own risk. To the fullest extent permitted by law the Event Organiser and Bristol Water are not responsible for, and shall not be held responsible by you for, any loss, injury, or damage howsoever caused (including any personal injury sustained by you in any way or any loss or damage to any personal property) except where any such loss, injury, or damage is caused by the negligence of the Event Organiser, or Bristol Water, or their respective its employees or agents. In consideration of participation in or attendance at the Event, you hereby release, discharge, and hold harmless the Event Organiser, Bristol Water, and their affiliated parties from any and all liability, claims, or damages arising out of your participation in or attendance at the Event to the fullest extent permitted by law.
28. You agree to indemnify and defend the Event Organiser, Bristol Water, and their affiliated parties against any claims, damages, costs, or liabilities (including legal fees) resulting from your registration to, participation in, and/ or attendance at the Event.
29. You are responsible for taking out suitable personal insurance and or medical and injury cover for your participation in the Event if you wish to do so.
30. You are responsible for the safe keeping of any personal possessions you may bring to the Event. Personal possessions brought to the Event at done so entirely at your own risk.
31. The Event Organisers are not responsible for any third-party organisations that may provide other services at the Event. You use any such services at your own risk.
32. Note that personal liability insurance, medical insurance, belongings/ equipment insurance, personal accident insurance, etc., are NOT provided by The Event Organiser or Bristol Water.

### **Personal data**

33. The use of photographic and video equipment by you is permitted for private domestic purposes, only. All other uses are prohibited, including (without limitation) sale, licensing, advertising, or any commercial use.
34. The Event Organiser and/ or Bristol Water will collect, store, and use your personal data for the purposes of the organisation and delivery of the Event. Such use will be in accordance with their respective Privacy Policies, links to which can be found below:

The Event Organiser/and or Bristol Water may publish images and footage of you and any other individual who accompanies you, including dependants, and use them in any media regarding the Event, including but not limited to Event gallery and subsequent promotional material to market and advertise the Event or similar events in the future. Please note that you are free to opt-out of the publication of any image or footage which identifies you or any other individual who accompanies you.
